DIRECTIONS TO PARKING STRUCTURE

- As you arrive on campus, inform the Welcome Center of your destination.
- Depart from the Welcome Center and proceed to the first stop sign
- Continue straight (slightly left) until the next stop sign.
- Turn Left and proceed on this road (Peppertree Lane).
- The road will slowly move to the right where you will see the main parking structure on your left.
- Guest parking is free.

Code of Conduct

All BATB Campers are expected to adhere to the following standards of conduct at all times:

- Use of language appropriate for a school function.
- Respect the rights, privacy and property of others.
- Respect the property and facilities of PLNU.
- Wear appropriate clothes for activities and rehearsals.
- All participants are to be in their assigned area at curfew and to comply with the quiet hours, lights out, and other rules of the camp.
- Obscene and discriminatory language, roughhousing, and insubordination will not be tolerated at any time.
- Campers are to hang out in common areas only, not individual rooms.
- Campers are only allowed to be in the wing they are assigned to.

Penalties for Infractions:

Infractions of this Code of Conduct must be reported promptly by anyone observing them to the Director who will be the final responsibility for disciplinary action. Penalties may include any or all of the following:

- sending a camper home.
- barring that camper from future BATB events.
- being assessed the cost of damages and repairs in the event of damage/destruction of property.
- being released to the nearest law enforcement agency and/or the proper authorities.

Parents will be notified of any action taken. If a camper is sent home, fees will not be refunded, and will be at the camper's own expense.
